2 **Resolution determining that the transfer of a Type 47 on-sale general eating place**
3 **liquor license to Keith L. Goodman for the Beer Cellar at 685 Sutter Street (District**
4 **6) and to exchange said license to a Type 48 on-sale general public premises, will**
5 **serve the public convenience and necessity of the people of the City and County**
6 **of San Francisco, in accordance with section 23958.4 of the California Business**
7 **and Professions Code; with conditions.**

9 WHEREAS, Keith L. Goodman is seeking transfer of a Type 47 on-sale general
10 eating place liquor license for the Beer Cellar located at 685 Sutter Street and to
11 exchange said license to a Type 48 on-sale general public premises; and,

12 WHEREAS, The City Planning Department has verified that the area is properly
13 zoned; and,

14 WHEREAS, The Police Department recommends that the liquor license
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business
17 and Professions Code, the Board of Supervisors of the City and County of San
18 Francisco hereby determines for the foregoing reasons that the transfer of a Type 47
19 on-sale general eating place liquor license to Keith L. Goodman for the Beer Cellar at
20 685 Sutter Street and to exchange said license to a Type 48 on-sale general public
21 premises, will serve the public convenience and necessity of the people of the City and
22 County of San Francisco.

23 Conditions: 1) Sales and service of alcoholic beverages shall be permitted only
24 between the hours of 5:00 p.m. and 2:00 a.m. each day of the week. 2) Live
25 entertainment provided shall be limited to a Disc Jockey and music shall not be audible

1 beyond the premises. 3) The petitioner(s) shall be responsible for maintaining free of
2 litter the area in front of and adjacent to the premises over which they have control.




