3 **Resolution urging the San Francisco Planning Department and Planning Commission**
4 **not to approve residential housing projects of ten units or more with less than a 10%**
5 **affordability requirement or 15% affordability requirement for conditional-use projects**
6 **and Planned Unit Developments (PUDs) prior to consideration by the Board of**
7 **Supervisors of legislation specifically codifying these new affordability levels.**

9 WHEREAS, Affordable housing is a paramount statewide concern, and the availability
10 of housing is of vital statewide importance; and,

11 WHEREAS, San Francisco faces a continuing shortage of affordable housing for very
12 low, low and median income residents; and,

13 WHEREAS, Affordable housing production in the City has averaged approximately 350
14 units per year during the past 10 years, while the demand for new affordable housing is
15 approximately 1,300 units per year; and,

16 WHEREAS, The San Francisco Planning Department reported that for the past ten
17 years, 3,199 units of low and very low-income housing were built in SF out of a total need of
18 15,103 units for the same period; and,

19 WHEREAS, The General Plan states that "[i]nclusion of affordable housing should be
20 required as a condition of approval of housing projects containing 10 or more units which seek
21 Planning Commission approval as conditional uses or planned unit developments;" and,

22 WHEREAS, The Planning Department and the Planning Commission do not currently
23 have a policy of requiring inclusionary housing for projects which do not require conditional
24 use approval or are not planned unit developments, thereby greatly limiting the already dismal
25 production of affordable housing; and,

1 WHEREAS, The Planning Department and the Planning Commission are presently
2 considering a review of their existing inclusionary guidelines, and the Board of Supervisors
3 would like to encourage the Commission to do so; and

4 WHEREAS, The San Francisco Board of Supervisors has before it pending legislation
5 sponsored by Supervisor Mark Leno that intends to apply a 10% inclusionary housing
6 requirement to all residential projects of 10 units or more and 15% for conditional use projects
7 and PUDs; and,

8 WHEREAS, Given the General Plan 10% inclusionary guideline, the Board's intent to
9 codify even higher levels, and the tremendous need for affordable housing; now, therefore be
10 it,

11 RESOLVED, that the City and County of San Francisco Board of Supervisors hereby
12 urges the San Francisco Planning Department and Planning Commission not to approve
13 residential housing projects of ten units or more with less than a 10% affordability requirement
14 or 15% affordability requirement for conditional-use projects and Planned Unit Developments
15 (PUDs) prior to consideration by the Board of Supervisors of legislation specifically codifying
16 these new affordability levels.


