8       RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
9 does hereby appoint the hereinafter designated persons to serve as members of the  
10 Emergency Room Diversion Task Force, pursuant to the provisions of Resolution 536-01, for  
11 the term specified:

12       Steven Polevei, new position, seat 2, must be an emergency room physician from the  
13 Emergency Physicians Association, term to be determined;

14       Alan Gelb (residency requirement waived), new position, seat 3, must be an  
15 emergency room physician from the San Francisco General Hospital, term to be determined;

16       Rebecca Goldfader, new position, seat 4, must be a nurse manager from a community  
17 hospital, term to be determined;

18       Abbie Yant, new position, seat 5, must be a nurse manager from a community hospital,  
19 term to be determined;

20       Andrew Bindman, new position, seat 6, must be a primary care specialist physician  
21 from the San Francisco General Hospital, term to be determined;

22       Ronald Smith, new position, seat 7, must represent the Hospital Council, term to be  
23 determined;

24       George Susens, new position, seat 8, must be a representative of the San Francisco  
25 Medical Society, term to be determined;

1 Michael Puccinelli, new position, seat 9, must be a representative of the San Francisco  
2 Police Department, term to be determined;

3 Kym Valadez (residency requirement waived), new position, seat 11, must represent a  
4 community based organization that serves the homeless and/or uninsured population, term to  
5 be determined;

6 Alissa Riker, new position, seat 12, must represent a community based organization  
7 that serves the homeless and/or uninsured population, term to be determined.; and, be it

8 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 9 1. The membership of the Emergency Room Diversion Task Force has a goal to be  
10 representative of the diversity of the City and County of San Francisco.
- 11 2. Applicants Alan Gelb and Kym Valadez, new appointees, who are not residents of  
12 San Francisco, are persons with experience that uniquely qualifies him/her to serve  
13 on Emergency Room Diversion Task Force.
- 14 3. The Emergency Room Diversion Task Force has attempted to fill the position, for  
15 which Alan Gelb and Kym Valadez were nominated, with individuals who are City  
16 residents and who have the specific experience, skills, and qualifications, but has  
17 been unable to do so at this time. The Rules Committee has certified that Alan  
18 Gelb and Kym Valadez are qualified to serve on the Emergency Room Diversion  
19 Task Force.
- 20 4. After exercising due diligence, the Board of Supervisors concludes that there are no  
21 other possible representative, who are residents of San Francisco and who have  
22 the specific experience, skills, or qualifications possessed by these applicants, and  
23 who are willing to serve on the Emergency Room Diversion Task Force at this time;

1           FURTHER RESOLVED, That the Board of Supervisors waives the residency  
2 requirement for Alan Gelb and Kym Valadez , as allowed in cases where no qualified City  
3 resident, willing to serve, can be found, pursuant to Section 4.101 of the City Charter that  
4 requires person(s) appointed to boards, commissions, and advisory bodies established by  
5 legislative act of the Board of Supervisors to be resident(s) of the City and County of San  
6 Francisco.


