3 Resolution approving the modification of the contract between the City and County of
4 San Francisco and the IHSS Consortium of San Francisco for the provision of In-Home
5 Supportive Services for the period from February 1, 2002 to June 30, 2004, in the
6 amount of \$18,458,757, for a total contract amount of \$47,673,130.

8 WHEREAS, The City and County of San Francisco approved the contract with the
9 IHSS Consortium of San Francisco, on file with the Clerk of the Board of Supervisors in File
10 No. 01-1092, which is hereby declared to be part of this resolution as if set forth fully herein;
11 and,

12 WHEREAS, The City and County of San Francisco wishes to provide In-Home
13 Supportive Services to additional eligible blind, aged, and disabled persons to enable these
14 individuals to remain safely in their homes; and,

15 WHEREAS, The Department of Human Services conducted a Request for Proposals
16 for these additional services in October 2001; and,

17 WHEREAS, The IHSS Consortium of San Francisco submitted a responsive and
18 responsible proposal and was awarded the contract, to be added on to its existing contract;
19 and,

20 WHEREAS, The Human Services Commission has recommended approval of this
21 contract modification with the IHSS Consortium of San Francisco at its meeting of December
22 21, 2001; now, therefore, be it

23 RESOLVED, That the Board of Supervisors hereby approves the modification of this
24 contract with the IHSS Consortium of San Francisco for the period of February 1, 2002 to
25 June 30, 2004, in the amount of \$18,458,757, for a total contract amount of \$47,673,130.




