12 specialist at Paul Revere Elementary School for 22 years, served as principal of Visitacion  
13 Valley Elementary School for two and one-half years, and served the Bay View Hunter's Point  
14 community, as principal of the Dr. George Washington Carver Academic Elementary School  
15 for 16 years; and,

16 WHEREAS, At Dr. George Washington Carver Academic Elementary School, Mrs.  
17 Jones devoted herself to the idea of excellence for all students, consistently raising the level  
18 of academic pursuits and always holding the highest of expectations for Achievers and Staff;

20 WHEREAS, Under her leadership, Dr. Carver Elementary was recognized nationally by  
21 Redbook Magazine as an outstanding school with student achievers consistently scoring  
22 above the national average in mathematics leading the school to achieve the status of  
23 California Distinguished Schools for the years of 1989, 1993, and 1997; and,

1           WHEREAS, Louise C. Jones served as Assistant Superintendent, Elementary  
2 Instructional Support and Operations for 3 years and served as Commissioner, Southeast  
3 Community College Facility for approximately 4 years; and,

4           WHEREAS, Louise C. Jones served on the Asthma Task Force and was instrumental  
5 in raising the awareness level and supporting the many children in the Bay View Hunter's  
6 Point Community suffering from asthma; and.

7           WHEREAS, Louise C. Jones received many awards, representing her dedication




