3 **Resolution appointing Roderick Kiracofe, term to be determined, to the United Nations**  
4 **Plaza Working Group, residency requirement waived.**  
5

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
7 does hereby appoint the hereinafter designated person to serve as a member of the United  
8 Nations Plaza Working Group, pursuant to the provisions of Motion No. 01-0140, for the term  
9 specified:

10 Roderick Kiracofe (residency requirement waived), new position, seat 2, must be a  
11 member of the Market Street Association, term to be determined; and, be it

12 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 13 1. The membership of the United Nations Plaza Working Group has a goal to be  
14 representative of the diversity of the City and County of San Francisco.
- 15 2. Applicant Roderick Kiracofe, a new appointee, who is not a resident of San  
16 Francisco, is a person with experience that uniquely qualifies him/her to serve on  
17 the United Nations Plaza Working Group.
- 18 3. The United Nations Plaza Working Group has attempted to fill the position, for  
19 which Roderick Kiracofe was nominated, with an individual who is a City resident  
20 and who has the specific experience, skills, and qualifications, but has been unable  
21 to do so at this time. The Rules Committee has certified that Roderick Kiracofe is  
22 qualified to serve on the United Nations Plaza Working Group.
- 23 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
24 other possible representative, who is a resident of San Francisco and who has the  
25

1 specific experience, skills, or qualifications possessed by this applicant, and who is  
2 willing to serve on the United Nations Plaza Working Group at this time; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors waives the residency  
4 requirement for Roderick Kiracofe, as allowed in cases where no qualified City resident,  
5 willing to serve, can be found, pursuant to Section 4.101 of the City Charter that requires  
6 person(s) appointed to boards, commissions, and advisory bodies established by legislative  
7 act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.




