3 **Resolution Authorizing the Chief of Police for the City and County of San Francisco to**
4 **retroactively accept and expend grant funds made available through the California**
5 **Office of Traffic Safety for a project entitled Safe and Sober in San Francisco Project;**
6 placing \$50,000 on reserve.

7 WHEREAS, the purpose of the project is to reduce the number of alcohol-involved
8 collisions, increase the number of DUI arrests and to educate the public about drinking and
9 driving; and,

10 WHEREAS, The San Francisco Police Department is proposing to accomplish this goal
11 by conducting a public information campaign to raise awareness of the general public
12 regarding the problems associated with drinking and driving and conduct enforcement
13 operations in the form of sobriety checkpoints in partnership with the California Highway
14 Patrol (CHP) during the Memorial Day, Labor Day, and Winter Holiday periods; and,

15 WHEREAS, The Chief of Police of the San Francisco Police Department desires to use
16 the grant to fund police operations to accomplish these goals; and,

17 WHEREAS, The Department proposes to maximize use of available grant funds on
18 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

19 RESOLVED, That the Chief of Police of the City and County of San Francisco is
20 authorized to execute on behalf of the Board of Supervisors of the City and County of San
21 Francisco the attached grant award including any extensions and funding augmentations from
22 the California Office of Traffic Safety, or amendments thereof; and be it

23 FURTHER RESOLVED, That the Chief of Police of the City and County of San
24 Francisco is authorized on behalf of the City and County of San Francisco to accept and
25 expend continued funding for this project, and, be it.

2 indirect costs in the grant budget; and be it

3 FURTHER RESOLVED, That a grant award notification has been received from the
4 California Office of Traffic Safety; and be it


5 FURTHER RESOLVED, That the City and County of San Francisco will adhere to the
6 intended use and reporting requirements of the California Office of Traffic Safety regarding the
7 Safe and Sober in San Francisco Project and all conditions specified in the grant agreement;
8 and be it

9 FURTHER RESOLVED, that it is agreed that any liability arising out of the performance
10 of this grant award, including civil court actions for damages, shall be the responsibility of the
11 grantee and the authorizing agency, and, be it

12 FURTHER RESOLVED, that the grant funds hereunder shall not be used to supplant
13 expenditures controlled by this body.

14 FURTHER RESOLVED, That the \$50,000 of contractual expenses be placed on reserve
15 pending the award of a contract and submission to the Public Works and Public Protec-
16 tion Committee of the Board of Supervisors of the contractor's estimated hours and
17 hourly rates.






