3 **Resolution authorizing the Municipal Transportation Agency to accept and expend**
4 **\$3,325,000 of Regional Measure One Funds for Municipal Railway Transit Project.**

6 WHEREAS, The Metropolitan Transportation Commission is authorized to make bridge
7 toll Net Revenue available pursuant to the Regional Measure One (RM1) program; and,

8 WHEREAS, The Municipal Transportation Agency, City and County of San Francisco,
9 is an eligible claimant for assistance pursuant to the RM1 program; and,

10 WHEREAS, The Bridge Toll Net Revenue RM1 program provides for \$3,325,000 of
11 capital assistance to the Municipal Transportation Agency for the purpose of constructing the
12 F-to-MMX connector; and,


13 WHEREAS, The Municipal Transportation Agency proposes to maximize use of
14 available grant funds on program expenditures by not including indirect costs in the grant
15 budget; now, therefore, be it

16 RESOLVED, That the Board of Supervisors authorizes the Municipal Transportation
17 Agency to accept and expend \$3,325,000 of Bridge Toll Net Revenue RM-1 Program funds
18 for the purposes of constructing the F-to-MMX connector project for the San Francisco
19 Municipal Railway; and, be it

20 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
21 indirect costs in the grant budget; and, be it

1 FURTHER RESOLVED, That the Municipal Transportation Agency is authorized to furnish
2 whatever additional information as might be requested by the funding agencies in connection
3 with this request.


