3 01-02 totaling \$579,000 and \$585,000 for FY 02-03 for various pedestrian and bicycle
4 improvements in San Francisco.]

5 **Resolution authorizing the Executive Director of the Department of Parking and Traffic**
6 **and the Director of the Department of Public Works to accept and expend state**
7 **Transportation Development Act Article 3 (TDA) funds totaling \$579,000 for FY 01-02**
8 **and \$585,000 for FY 02-03 for various pedestrian and bicycle projects in the City and**
9 **County of San Francisco.**

10 WHEREAS, Article 3 of the Transportation Development Act (TDA), Public Utilities
11 Code (PUC) Section 99200 et seq. authorizes the submission of claims to a regional
12 transportation planning agency for the funding of projects exclusively for the benefit and/or
13 use of pedestrians and bicyclists; and,

14 WHEREAS, The Metropolitan Transportation Commission (MTC), as the regional
15 transportation planning agency for the San Francisco Bay region, provides for the
16 disbursement of funds in the nine-county Metropolitan Transportation Commission region for
17 bicycle and pedestrian purposes; and,

18 WHEREAS, the Departments of Parking and Traffic and Public Works of the City and
19 County of San Francisco are eligible to request allocations of TDA Article 3 funds to support
20 various pedestrian and bicycle improvements as described below; and,

21 WHEREAS, The Department of Parking and Traffic has identified the following projects
22 to be funded with FY 01-02 TDA funds totaling \$274,000 for bicycle improvements: 1) Various
23 Bicycle and Pedestrian Safety Projects such as safety brochures, maps, telephone hotline,
24 and advertising (\$27,400); 2) Striping of Class II Bikeways (bike lanes) at various locations in

1 San Francisco as recommended in the San Francisco Bicycle Plan (\$100,000); 3)
2 Improvements to Class III Bikeways (bike routes) by Widening Curb Lanes Striping Bicycle
3 Pavement Arrows at various locations in San Francisco (\$46,000); and, 4) Installation of
4 Bicycle Parking Facilities (racks, lockers, Bike Stations) at various location in San Francisco
5 as recommended in the San Francisco Bicycle Plan (\$100,000); and,

6 WHEREAS, the Department of Parking and Traffic has identified the following projects
7 to be funded with FY 02-03 TDA funds totaling \$310,000 for bicycle improvements: 1) Various
8 Bicycle and Pedestrian Safety Projects such as safety brochures, maps, telephone hotline,
9 and advertising (\$31,000); 2) Striping of Class II Bikeways (bike lanes) at various locations in
10 San Francisco as recommended in the San Francisco Bicycle Plan (\$100,000); 3)
11 Improvements to Class III Bikeways (bike routes) by Widening Curb Lanes Striping Bicycle
12 Pavement Arrows at various locations in San Francisco (\$79,000); and, 4) Installation of
13 Bicycle Parking Facilities (racks, lockers, Bike Stations) at various location in San Francisco
14 as recommended in the San Francisco Bicycle Plan (\$100,000); and,

15 WHEREAS, The San Francisco Bicycle Advisory Committee, at its November 29, 2001
16 meeting, reviewed and approved the DPT list of FY 01-02 and FY 02-03 TDA Projects and
17 recommended that TDA funds be applied for; and,

18 WHEREAS, The Parking and Traffic Commission has approved Resolution No. 179-
19 01-PTC at its December 18, 2001 meeting authorizing the Executive Director of the
20 Department of Parking and Traffic or his designee to execute documents necessary to apply
21 for, accept and expend \$274,000 of fiscal year 2001-02 and \$310,000 of fiscal year 2002-03
22 TDA Article 3 funds for various bicycle and pedestrian programs; and,

23 WHEREAS, The Department of Public Works has identified the following projects to be
24 funded with FY 01-02 TDA funds totaling \$305,000 to improve pedestrian safety and access:
25 1) Installation of two (2) Light Fixtures at Francisco Stairs (\$28,000); 2) Installation of Fencing

1 on the Median of Geary Boulevard between Scott and Steiner Streets (\$23,000); 3)
2 Pedestrian Improvements at the Downtown Ferry Terminal Public Pier (\$50,000); 4)
3 Construction/Reconstruction of Curb Ramps for Compliance with the Americans with
4 Disability Act (\$127,000); and, 5) Mission St. Corridor (Ocean/Geneva) Pedestrian
5 Improvement Project – Design Phase (\$77,000); and,

6 WHEREAS, The Department of Public Works proposes using its FY 2002-03 allocation
7 of \$275,000 for the preliminary engineering, design and the construction and/or
8 reconstruction of curb ramps as required by the federal Americans with Disabilities Act; and,

9 WHEREAS, the Departments of Public Works and Parking and Traffic have consulted
10 with the appropriate staff at the Planning Department of the City and County of San Francisco
11 to ensure compliance with the requirements of the California Environmental Quality Act
12 (CEQA, Public Resources Code Sections 21000 et seq.) and have in their possession
13 documents certifying the Planning Department's determination that the aforementioned
14 Departments are in fact in compliance with the necessary environmental requirements to
15 implement their projects; and,

16 WHEREAS, the Departments of Public Works and Parking and Traffic have consulted
17 with the City Attorney of the City and County of San Francisco to confirm that there is no
18 pending or threatened litigation that might adversely affect their projects or that may impair
19 the ability of the Departments to carry out their projects and have in their possession a legal
20 opinion of counsel certifying the City Attorney has made a determination that the
21 aforementioned projects are free from pending or threatened litigation; and,

22 WHEREAS, Indirect costs are ineligible according to state rules and regulations; now,
23 therefore, be it

24 RESOLVED, That this Board of Supervisors does hereby authorize the Director of the
25 Department of Public Works and the Executive Director of the Department of Parking and


