8 2001 the Mayor approved Resolution 011404 establishing the Presidio Neighborhood
9 Representative Work Group; and,

10 WHEREAS, The Presidio Neighborhood Representative Work Group representatives
11 included a broad range of citizen and City Department representatives; and

12 WHEREAS, The Presidio Neighborhood Representative Work Group has been
13 meeting to develop the commentary on the Presidio Trust Implementation Plan (PTIP) and
14 Environmental Impact Statement (EIS); and

15 WHEREAS, The Work Group representatives submitted comments to the Presidio
16 Trust following the distribution of the PTIP; and

17 WHEREAS, The Work Group is to report any of its findings, concerns or
18 recommendation to the Board of Supervisors during and beyond the 60 day PTIP
19 recommendation comment period regarding the Presidio now, therefore, be it

20 RESOLVED, That the Board of Supervisors schedule a Meeting of the Whole on July
21 1, 2002 on the efforts of the Presidio Neighborhood Representative Work Group; and, be it

22 FURTHER RESOLVED, That the City Attorney shall prepare and present a written
23 report to the Board of Supervisors at the July 1, 2002 meeting regarding the adequacy of the
24 Presidio Trust's responses to the City's comments on the PTIP and the EIS.
