10 WHEREAS, The San Francisco Planning Department and its partners, the San
11 Francisco Bay Area Rapid Transit District (BART) and the San Francisco Public Library,
12 desire to undertake a community planning process to enhance community livability and to
13 improve overall transportation circulation within the one-quarter mile radius of the Glen Park
14 BART station; and,

15 WHEREAS, The Planning Department has applied for a Community-Based
16 Transportation Planning Grant from the California Department of Transportation (Caltrans) to
17 fund this undertaking; and,

18 WHEREAS, Caltrans has notified the Planning Department that the Glen Park BART
19 Station Area Plan Project was awarded a Community-Based Transportation Planning Grant in
20 the amount of \$80,000; and,

21 WHEREAS, Caltrans has agreed to provide funding for this planning project with its
22 State Highway Account Community-Based Transportation Planning funds for fiscal year
23 2001-02; and,


24 WHEREAS, The aforementioned state funds will cover eighty (80) percent of the
25 eligible costs as administered by Caltrans; and,


1 WHEREAS, The Planning Department will provide \$20,000 in departmental funds for
2 its non-state share; and,


3 WHEREAS, Indirect costs are ineligible according to state rules and regulations; now,




