5 RESOLVED, That, in accordance with the provisions of the California Vehicle
6 Code and the San Francisco Traffic Code, the following regulations governing the
7 parking of vehicles are hereby enacted or rescinded as designated below:

9 **RESIDENTIAL PERMIT PARKING AREA "J" (TWO-HOUR TIME LIMIT, 8 AM - 5 PM,
MONDAY THROUGH FRIDAY) - ESTABLISH**

10 Waller Street, both sides, between Belvedere and Cole Streets.

11
12 **RESIDENTIAL PERMIT PARKING AREA "Z" (TWO-HOUR TIME LIMIT, 8 AM - 6 PM,
MONDAY THROUGH FRIDAY) - ESTABLISH**

13 3301-3303 Mission Street, between Fair and Virginia Avenues (adds specified
14 addresses only).

15 **TOW-AWAY, NO STOPPING, 7 AM TO 9 AM, MONDAY THROUGH FRIDAY -**
16 **RESCIND**
17 **TOW-AWAY, NO STOPPING, 6 AM TO 10 AM AND 3 PM TO 7 PM, MONDAY**

1 **TOW-AWAY, NO STOPPING ANYTIME - RESCIND**

2 Natick Street, east side, from 126 feet to 135 feet south of Chenery Street
3 (nine-foot portion of existing zone).

4 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

5 St. Charles Avenue, east side, between the County line and Niantic Avenue;

6 St. Charles Avenue, west side, between BART parking lot entrance
7 (approximately 82 feet south of Niantic Avenue) and the County line;

8 Tennessee Street, east side, from 70 feet to 160 feet north of Cesar Chavez
9 Street (90-foot zone); and

10 Ashbury Street, west side, from Downey Street to 15 feet northerly.

16 **PARKING METER AREA NO. 3 (ONE-HOUR PARKING TIME LIMIT, 9 AM - 6 PM,**
17 **MONDAY THROUGH SATURDAY) - EXTEND**

18 2nd Street, east side, between King and Townsend Streets.

19 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

20 Wisconsin Street, west side, from 124 feet north of 23rd Street to Madera Street;

21 Minnesota Street, east side, from 18th Street to 200 feet southerly;

22 Minnesota Street, west side, from 19th to 20th Streets; and,

23 19th Street, north side, from Minnesota Street to 95 feet easterly.

24 **ANGLED (60-DEGREE ANGLE) PARKING - ESTABLISH**

25 Missouri Street, east side, from 23 feet to 134 feet north of Cesar Chavez Street.

1 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

2 16th Street, south side, from 247 feet to 293 feet west of Potrero Avenue (46 foot
3 zone).

4 *Note: The Tow-Away restriction is being established to accommodate a DPW*

6 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

7 Taylor Street, west side, from 70 feet to 94 feet north of Clay Street
8 (accommodating seven motorcycle spaces).

PARKING METER AREA NO. 3 (ONE-HOUR PARKING TIME LIMIT, 9 AM - 6 PM, MONDAY THROUGH SATURDAY) - EXTEND
2nd Street, east side, between King and Townsend Streets.

PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH
Wisconsin Street, west side, from 124 feet north of 23rd Street to Madera Street;
Minnesota Street, east side, from 18th Street to 200 feet southerly;
Minnesota Street, west side, from 19th to 20th Streets; and,
19th Street, north side, from Minnesota Street to 95 feet easterly.

ANGLED (60-DEGREE ANGLE) PARKING - ESTABLISH

Missouri Street, east side, from 23 feet to 134 feet north of Cesar Chavez Street.

TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH

16th Street, south side, from 247 feet to 293 feet west of Potrero Avenue (46 foot zone).

Note: The Tow-Away restriction is being established to accommodate a DPW proposal to widen the sidewalk and install an automatic public toilet.

UNMETERED MOTORCYCLE PARKING - ESTABLISH

Taylor Street, west side, from 70 feet to 94 feet north of Clay Street (accommodating seven motorcycle spaces).

Categorically exempt from Environmental Review Class 1(c)(9) changes in the traffic and parking regulations where such changes do not establish a higher speed limit or result in more than a negligible increase in the use of the street.


