WHEREAS, KPOO, 89.5 fm, broadcasts live both the regularly scheduled meetings of the San Francisco Board of Supervisors and the San Francisco Redevelopment Agency; and,

WHEREAS, KPOO receives funding from the San Francisco Redevelopment Agency for broadcasting the agency's Commission hearings but does not receive funding by the Board of Supervisors to broadcast it's meetings; and,

WHEREAS, Because of the Board's rule change, KPOO will no longer be able to broadcast live the weekly meetings of the Board of Supervisors; and,

WHEREAS, Many members of the public, especially those involved in housing and land-use issues, have an interest in issues before both the San Francisco Board of Supervisors and the San Francisco Redevelopment Agency and often need to attend both of their meetings; now, therefore, be it

RESOLVED, That the San Francisco Board of Supervisors urges the San Francisco Redevelopment Agency Commission to move it's regularly scheduled meetings from Tuesdays to Mondays.
