4 **for organizing a successful Resource Job Fair for displaced airport security screeners**

8 WHEREAS, 950 airport security screeners from San Francisco International Airport
9 (SFO), instrumental in providing for the safety of travelers at SFO, were laid off in November
10 2002; and,

11 WHEREAS, Of those 950 airport security screeners, only 140 were rehired by
12 Covenant Aviation Security as security screeners and many of the rest remain unemployed;
13 and,

14 WHEREAS, On February 28, 2003, the South of Market Employment Center/Mission
15 Hiring Hall hosted a Resource Job Fair where over 350 displaced security screeners were
16 able to access career counseling, immediate employment opportunities and training program
17 information; and,

18 WHEREAS, dozens of groups participated in the event including the San Francisco
19 Labor Council which provided hundreds of bags of groceries to the screeners, STEPS Health
20 Care Network which provided healthcare information for laid off workers, Employment
21 Development Department, Social Security Administration, Asian Law Caucus, P.A.W.I.S.,
22 International Rescue Committee, Franchise Tax Board, and the Private Industry Council; and,

23 WHEREAS, Dioscoro Recio, from South of Market Employment Center helped
24 organize this successful event, which provided essential resources and empowerment to the
25 displaced airport workers; now, therefore be it




