3 **Resolution Authorizing the Chief of Police for the City and County of San Francisco to**
4 **accept and expend grant funds made available through the California Department of**
5 **Boating and Waterways to purchase a replacement patrol boat.**

7 WHEREAS, The purpose of this grant is to purchase a replacement patrol boat, to be
8 used by the San Francisco Police Department Marine Unit exclusively for boating safety and
9 law enforcement; and,

10 WHEREAS, benefits provided through this State Program will enable the Police
11 Department to more effectively enforce laws and promote boating safety; and,

12 WHEREAS, the Chief of Police of the City and County of San Francisco is authorized
13 on behalf of the City and County of San Francisco to apply, accept and expend continued
14 funding for this program from the California Department of Boating and Waterways, and

15 WHEREAS, The grant terms prohibit including indirect costs in the grant budget now,
16 therefore, be it

17 RESOLVED, That the Chief of Police of the City and County of San Francisco is
18 authorized to execute on behalf of the City and County of San Francisco the necessary Grant
19 Award Agreement for this program including any extensions, amendments, funding
20 augmentations from the California Department of Boating and Waterways; and be it

21 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
22 indirect costs in the grant budget; and be it

23 FURTHER RESOLVED, That the San Francisco Police Department shall be
24 responsible for the costs of operating and maintaining the patrol boat in good repair;
25 and be it

1 FURTHER RESOLVED, That the San Francisco Police Department at its own
2 expense, agrees to replace the patrol boat if it is destroyed or rendered useless prior to the
3 expiration of this contract; and be it


4 FURTHER RESOLVED, That this patrol boat shall be kept available for search and
5 rescue operations; and be it

6 FURTHER RESOLVED, The California Department of Boating and Waterways shall be
7 the legal owner of the patrol boat and the San Francisco Police Department shall be the
8 registered owner and shall not assign, mortgage, hypothecate or transfer its interest in the
9 patrol boat without prior written approval of the California Department of Boating and
10 Waterways; and be it

11 FURTHER RESOLVED, that it is agreed that any liability arising out of the performance
12 of this Grant Award Agreement, including civil court actions for damages, shall be the
13 responsibility of the City and the San Francisco Police Department; and be it


14 FURTHER RESOLVED, that grant funds received hereunder shall not be used to
15 supplant expenditures controlled by this body.


