[Accept-Expend Regional Grant]

Resolution authorizing the Department of the Environment to accept and expend a grant in the amount of \$440,984 from the Bay Area Air Quality Management District for retrofitting six heavy-duty vehicles to Liquid Natural Gas.

WHEREAS, the Bay Area Air Quality Management District has awarded funds to the Department of the Environment to assist Norcal Waste Systems, Inc. to retrofit the engines of six (6) new heavy-duty trucks from diesel to Liquid Natural Gas; and,

WHEREAS, the Department of the Environment shall require that Norcal Waste Systems, Inc. operate the vehicles retrofitted with this grant within the boundaries of the Air District for a minimum of ten (10) years; and,

WHEREAS, the Department of the Environment shall require that Norcal Waste Systems, Inc. dismantle and scrap six (6) older diesel-powered refuse vehicles or equivalent vehicles in the Norcal fleet; and,

WHEREAS, the Board of Supervisors for the City and County of San Francisco has directed the Department of the Environment to reduce CO₂ emissions within the City and County of San Francisco to 20% below 1990 levels by the year 2012; and,

WHEREAS, retrofitting the engines of the six (6) heavy-duty vehicles to Liquid Natural Gas will result in reduced CO₂ emissions within the City and County of San Francisco; and,

WHEREAS, The grant budget includes provision for indirect costs of \$20,984; now, therefore, be it


