

1 [Apply for, Accept and Expend State Grant]

3 **Resolution authorizing the Department of the Environment to apply for, accept and**  
4 **expend a grant in the amount of \$189,938 from the California Integrated Waste**  
5 **Management Board for enforcing proper disposal of waste tires.**

7 WHEREAS, Senate Bill 876 requires the California Integrated Waste Management  
8 Board to consider designating a city or county, or city and county as the enforcement authority  
9 of regulations relating to the storage and handling of waste and used tires; and,

10 WHEREAS, Senate Bill 876 also requires that if the Board designates a local entity for  
11 this purpose, it provides sufficient, stable, and noncompetitive funding; and,

12 WHEREAS, the Department of the Environment is applying for funding of \$189,938 for  
13 waste tire enforcement; and,

14 WHEREAS, the California Integrated Waste Management Board requires that all  
15 applicants for the Waste Tire Enforcement Program must submit an "apply for" resolution to  
16 the Board of Supervisors; and,

17 WHEREAS, the City and County of San Francisco project sponsors who are  
18 designated to receive Waste Tire Grant funds shall submit all required additional information  
19 for the Board of Supervisor's consideration of an "accept and expend" resolution; and,

20 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,  
21 therefore, be it

22 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
23 the grant budget; and be it


24 FURTHER RESOLVED, That the San Francisco Board of Supervisors authorizes the




