13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48  
20 on-sale general public premises license from #1 Embarcadero Center to 682-684  
21 Commercial Street for Chun Mie and Kam Leung Li, dba "EC5"; will serve the public  
22 convenience and necessity of the people of the City and County of San Francisco.

23 Conditions: (1) Sales and services of alcoholic beverages shall be permitted only  
24 between the hours of 12 noon and 2:00 a.m. each day of the week; (2) The petitioner(s)  
25 shall be responsible for maintaining free of litter the area in front of and adjacent to the

1 premises over which they have control; and (3) The petitioner(s) shall police the area  
2 under their control in an effort to prevent the loitering of persons about the premises.




