9 undertake a certain project designated "Suppression of Drug Abuse in Schools Program" to  
10 be funded in part from funds made available through the Governor's Office of Criminal Justice  
11 Planning (herein referred to as OCJP); and,

12 WHEREAS, The grant budget includes provision for indirect costs, now, therefore,  
13 be it

14 RESOLVED, That the Chief of Police of the City and County of San Francisco is  
15 authorized on behalf of the City and County of San Francisco to retroactively accept and  
16 expend continued funding for this project from OCJP; and be it

17 FURTHER RESOLVED, That the Chief of Police is authorized to execute on behalf of  
18 the City and County of san Francisco the necessary Grant Award Agreement for this project  
19 including any extensions, funding augmentations from OCJP, or amendments thereof; and be  
20 it

21 FURTHER RESOLVED, That it is agreed that any liability arising out of the  
22 performance of this Grant Agreement, including civil court actions for damages, shall be the  
23 responsibility of the City and the San Francisco Police Department. The State of California  
24 and OCJP disclaim responsibility for any such liability; and be it


