3 **RESOLUTION AUTHORIZING THE MAYOR'S OFFICE OF EMERGENCY SERVICES TO**  
4 **ACCEPT AND EXPEND A GRANT IN THE AMOUNT OF \$179,451 FROM THE**  
5 **CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES FOR EMERGENCY**  
6 **OPERATIONS PLANNING.**

8 WHEREAS, the City and County of San Francisco maintains emergency operations  
9 plans to coordinate the actions of departments and agencies in times of crisis; and,

10 WHEREAS, The 2002 Supplemental Appropriations Act for Further Recovery From  
11 and Response to Terrorist Attacks on the United States (Public Law 107-206) authorizes  
12 federal funding to State and local governments for the updating of emergency operations  
13 plans; and,

14 WHEREAS, The California Governor's Office of Emergency Services has been  
15 delegated responsibility for the administration of these funds within California and grant funds  
16 are available from the Governor's Office of Emergency Services for emergency operations  
17 planning; and,

18 WHEREAS, The grant budget includes provision for indirect costs of \$8,972; now,  
19 therefore, be it

20 RESOLVED, That the Board of Supervisors hereby authorizes the Director of the  
21 Mayor's Office of Emergency Services to accept and expend an emergency operations  
22 planning grant of up to \$179,451 from the California Governor's Office of Emergency Services  
23 to fund updating emergency operations plans for the City and County of San Francisco; and

1 FURTHER RESOLVED, That the Director of the Mayor's Office of Emergency Services  
2 is hereby authorized and empowered to execute, deliver, and perform, in the name of the City  
3 and County of San Francisco, all applications, contracts, agreements, amendments and  
4 payment requests necessary for the purpose of securing such emergency operations planning  
5 grant funds and to implement and carry out the purposes specified in the applicable grant  
6 application.




