16 Diabetes, Anxiety, Depression, Glaucoma, and others; and,

17 WHEREAS, The Tenth Street Compassion and Care Center provides massage
18 therapy, acupuncture, daily food and beverage selections; and,

19 WHEREAS, Each center hosts meetings, special events, and parties that benefit the
20 Medical Cannabis Community; now therefore be it

21 RESOLVED, That the City and County of San Francisco Board of Supervisors hereby
22 commends Robert Martin and the staff of The Tenth Street and Church Street Compassion
23 and Care Center for providing safe access, compassionate care, and numerous services to
24 San Franciscans who use Medical Cannabis to alleviate pain and suffering from serious
