[Apply For-State/Regional Grant]

Resolution authorizing the City Administrator to apply for a grant in the amount of \$864,000 from the Bay Area Air Quality Management District for the purpose of implementing programs to improve air quality.

WHEREAS, Assembly Bill 434 created the Transportation Fund for Clean Air in the Bay Area and provided authority to the Bay Area Air Quality Management District (the District) to impose up to a \$4.00 surcharge on motor vehicle registration fees within its jurisdiction, to be used to implement specified transportation control measures included in the District's 1991 Bay Area Clean Air Plan; and

WHEREAS, the District has approved a surcharge on motor vehicles and is seeking applications from Bay Area cities, counties, school districts and other agencies to cover the cost of transportation programs and projects that achieve emission reductions from motor vehicles; and

WHEREAS, the City and County of San Francisco supports the Bay Area Clean Air Plan; and

WHEREAS, the following city departments have developed programs and projects eligible for AB 434 program funding; the Department of the Environment in the amount of \$500,000 to subsidize the conversion of curbside refuse trucks engines from diesel to Liquified Natural Gas, for Norcal Waste Systems, Inc. and the Department of Parking and Traffic in the amounts of \$99,000 to purchase and install bike racks at various locations throughout the City, \$175,000 to build bike lanes on Alemany Boulevard between San Jose Avenue and Lyell Street, \$15,000 to build bike lanes on Folsom Street between 11th and 14th Streets, and \$75,000 to build bike lanes on Illinois Street between 16th and Islais Creek; and

WHEREAS, the District requires all applications to be authorized by the applicant's governing board, or in this case, the Board of Supervisors; and

WHEREAS, an accept and expend resolution and any additional necessary documentation will be provided, as required, in the event any of these projects are designated for District funding awards; now, therefore, be it

RESOLVED, that the City Administrator, on behalf of the above named departments, is authorized to apply for funding from the Transportation Fund for Clean Air for the programs to reduce air pollution from motor vehicles.
