Conditions: 1) The sale and service of alcoholic beverages shall be permitted only between the hours of 10:00 a.m. and 2:00 a.m. each day of the week; 2) Petitioner shall regularly police the area under their control in an effort to prevent the loitering of

persons about the premises; 3) The petitioner shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control; and shall maintain a contract for steam cleaning services as long as they have the business; 4) Entertainment provided shall not be audible beyond the area under control of the licensee; 5) The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
