3 **Resolution acknowledging and commending House Democratic Leader Nancy Pelosi**
4 **for her role in securing federal funding essential to the Central Subway, Phase II of the**
5 **Third Street Light Rail project, and other transportation infrastructure projects that will**
6 **benefit San Francisco and the region.**

8 WHEREAS, The Municipal Transportation Agency (MTA), the Board of Supervisors,
9 and the people of San Francisco are investing in our Transportation future with the Third
10 Street Light Rail project and its northernmost extension, the Central Subway; and,

11 WHEREAS, The Central Subway will bring great economic benefits to the City and the
12 region, but requires significant capital dollars from local, State, and Federal sources; and,

13 WHEREAS, House Democratic Leader Pelosi worked to secure \$9 million for the
14 Central Subway project, \$2.5 million related to the Muni Third Street Light Rail project, \$4
15 million for improvements to Muni bus facilities, and \$1.5 million for Muni to upgrade
16 communications systems to integrated radio and wireless data systems, and other
17 transportation related funds among the programs to be funded out of the \$820 billion fiscal
18 year 2004 Omnibus spending package; and,

19 WHEREAS, House Democratic Leader Pelosi worked to provide language to ensure
20 that the over \$500 million local investment already made in Phase I of the Third Street Light
21 Rail Project is recognized as local match for the entire Third Street project, thereby leveraging
22 future federal funds; and,

23 WHEREAS, Federal funding secured by House Democratic Leader Pelosi is vital to the
24 improvement and maintenance of the transportation infrastructure in San Francisco and the
25 region; now, therefore, be it

1 RESOLVED, That the Board of Supervisors acknowledges and commends House
2 Democratic Leader Nancy Pelosi for her role in securing federal funding essential to the
3 Central Subway, Phase II of the Third Street Light Rail project, and other transportation
4 infrastructure projects that will benefit San Francisco and the region.


