2 **Resolution enacting and rescinding traffic regulations on various streets.**

3 RESOLVED, That, in accordance with the provisions of the California Vehicle  
4 Code and the San Francisco Traffic Code, the following regulations governing the  
5 movement of vehicles are hereby enacted or rescinded as designated below:

6 **BICYCLE LANES - ESTABLISH**

7 Oakdale Avenue, both directions, from Phelps Street to 180 feet west of 3<sup>rd</sup>  
8 Street and from 3<sup>rd</sup> Street to 80 feet easterly.

9 **RIGHT TURN ONLY - RESCIND**

10 21<sup>st</sup> Street, eastbound and westbound, at Guerrero Street.

11 **NO LEFT TURN EXCEPT MUNI AND TAXIS FROM 3 PM TO 7 PM (SIX-MONTH**  
12 **TRIAL) - ESTABLISH**

13 Northbound Potrero Avenue to westbound 24th Street; and  
14 Eastbound 24<sup>th</sup> Street to northbound Potrero Avenue.

15 **STREET CLOSURE, 10 AM to 3 PM, MONDAY THROUGH FRIDAY - ESTABLISH**

16 Leidesdorff Alley, between Halleck and Sacramento Streets.

17 **ONE-WAY (NORTHBOUND) TRAFFIC DESIGNATION - ESTABLISH**

18 Arago Street, between Havelock and Paulding Streets.

19 Categorically exempt from Environmental  
20 Review Class 1(c)(9) changes in the traffic and  
21 parking regulations where such changes do not  
22 establish a higher speed limit or result in more  
23 than a negligible increase in the use of the  
24 street.


