9 WHEREAS, The Transportation Equity Act For The 21st Century provides funds to the
10 State of California for grants to state, local and non-profit organizations to acquire, develop
11 and/or maintain motorized and non-motorized trail purposes; and

12 WHEREAS, The State Department of Parks and Recreation has been delegated the
13 responsibility for the administration of the program within the State, setting up necessary
14 procedures governing project application under the program; and

15 WHEREAS, Said procedures established by the State Department of Parks and
16 Recreation require the applicant to certify by resolution the approval of application(s) before
17 submission of said application(s) to the State; and

18 WHEREAS, The applicant will enter into an agreement with the State of California to
19 complete the project(s); and

20 WHEREAS, The grant terms prohibit including indirect costs in the grant budget;
21 NOW, THEREFORE, BE IT RESOLVED that the City and County of San Francisco Board of
22 Supervisors hereby:


- 23 1. Approves the acceptance and expenditure of \$220,000 for improvements to the trails


