2 **Resolution enacting and rescinding traffic regulations on various streets.**

3 RESOLVED, That, in accordance with the provisions of the California Vehicle
4 Code and the San Francisco Traffic Code, the following regulations governing the
5 movement of vehicles are hereby enacted or rescinded as designated below:

6 **YIELD SIGN - ESTABLISH**

7 Potrero Avenue/Cesar Chavez Street/Southbound 101 Off-Ramp at Bayshore
8 Boulevard, southbound (eastbound).

9 **NO TURN ON RED - ESTABLISH**

10 Market Street, westbound, at Davis and Pine Streets.

11 **RIGHT LANE MUST TURN RIGHT - RESCIND**
12 **RIGHT LANE MUST TURN RIGHT EXCEPT MUNI - ESTABLISH**

13 Clay Street, eastbound, at Davis Street.

14 **RIGHT TURN ONLY - ESTABLISH**

15 Fowler Avenue, southbound, at Teresita Boulevard.

16 **YIELD SIGN - ESTABLISH**

17 Teresita Boulevard, southbound, at Fowler Avenue.

18 **NO RIGHT TURN ON RED INTO MARKET STREET - RESCIND**
19 **NO RIGHT TURN ON RED - ESTABLISH**

20 Castro Street, northbound, at Market Street.

21 **NO TURN ON FLASHING RED - RESCIND**
22 **NO TURN ON RED - ESTABLISH**

23 Church Street, northbound, at Market Street.

24 Categorically exempt from Environmental Review
25 Class 1(c)(9) changes in the traffic and parking
regulations where such changes do not establish
a higher speed limit or result in more than a
negligible increase in the use of the street.




