3 **Resolution authorizing the Department of the Environment to accept and expend a**
4 **grant in the amount of \$50,000 from the Pacific Gas and Electric Company to support**
5 **the development of a hydrogen fueling infrastructure in the City and County of San**
6 **Francisco.**

8 WHEREAS, the Pacific Gas and Electric Company has awarded funds to the
9 Department of the Environment for the development of a hydrogen fueling infrastructure to
10 support a hydrogen fuel cell vehicle pilot project; and,

11 WHEREAS, as part of their ongoing effort to combat global warming and other
12 environmental problems, the City's Commission on the Environment and its Board of
13 Supervisors have passed resolutions declaring San Francisco a "Hydrogen City"; and,

14 WHEREAS, the resolutions call for the City and County of San Francisco to seek pilot
15 projects using hydrogen as a clean alternative fuel; and,

16 WHEREAS, to explore the opportunities presented by this zero-emission vehicle
17 technology, the San Francisco Department of the Environment (SF Environment) has been
18 seeking ways to partner on such pilot demonstration projects with several automakers; and,

19 WHEREAS, SF Environment and the City and County of San Francisco have been
20 selected by Honda Motor Co. to participate in a fuel cell vehicle pilot project that will include
21 the leasing of two Honda FCX fuel cell vehicles and temporary hydrogen refueling
22 infrastructure; and,


23 WHEREAS, this grant will go towards the cost of leasing of the vehicles and fueling
24 infrastructure; and,

1 WHEREAS, the grant budget includes provision for indirect costs of \$4,545; now,
2 therefore, be it

3 RESOLVED, that the Board of Supervisors hereby authorizes the Director of the
4 Department of the Environment to accept and expend \$50,000 from the Pacific, Gas and
5 Electric Company to support the development of a hydrogen fueling infrastructure in the City
6 and County of San Francisco.




