Resolution authorizing the Department of Human Services to request an ABAWD Waiver from the State Department of Social Services.

WHEREAS, The Department of Human Services provides food stamps to eligible San Francisco residents; and,

WHEREAS, Eligible recipients (Able Bodied Adults without Dependents – ABAWDS) of food stamp benefits are limited to receiving the benefit for three months within a three year period of time for able bodied adults who are not working, participating in a work program for 20 hours or more each week, or in workfare; and,

WHEREAS, The State of California can issue waivers to counties, including San Francisco, that would allow the Department of Human Services to continue to issue food stamps to ABAWDS beyond the three months within a three year time period; and,

WHEREAS, The State of California can issue the aforementioned waivers for either the entire county or part of the county based upon having a local unemployment rate in excess of 10%, or in excess of 20% of the national unemployment rate; and,

WHEREAS, San Francisco County has sub-county areas that have consistently had local unemployment rates in excess of 10% and/or 20% above the national unemployment rate; and,

WHEREAS, High unemployment rates make it increasingly more difficult for individuals to obtain and maintain employment within their own community; now, therefore, be it

RESOLVED, That the Board of Supervisors authorizes the Department of Human Services to request consideration for an ABAWD waiver through the State of California to
