6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
7 does hereby appoint the hereinafter designated persons to serve as members of the  
8 Immigrant Rights Commission, pursuant to the provisions of Ordinance No. 211-97, for the

10 Vera Haile, succeeding herself, term expired, seat 1, must have a demonstrated  
11 knowledge of and interest in the health, human service, educational, or employment issues  
12 that affect immigrants residing in San Francisco, for a two-year term ending June 6, 2006.

13 Gilbert Alexander, succeeding Saif Ataya, term expired, seat 2, must have a  
14 demonstrated knowledge of and interest in the health, human service, educational, or  
15 employment issues that affect immigrants residing in San Francisco, for a two-year term  
16 ending June 6, 2006.

17 Solomon Jones, succeeding Tamara Ribas, term expired, seat 3, must have a  
18 demonstrated knowledge of and interest in the health, human service, educational, or  
19 employment issues that affect immigrants residing in San Francisco, for a two-year term  
20 ending June 6, 2006.

21 Ivy Lee, succeeding Larisa Casillas, term expired, seat 5, must have a demonstrated  
22 knowledge of and interest in the health, human service, educational, or employment issues  
23 that affect immigrants residing in San Francisco, for a two-year term ending June 6, 2006.

24 Houston Zheng, succeeding himself, term expired, seat 9, must be an immigrant to the  
25 United States who is appointed in accordance with Section 4.101 of the Charter. In addition,

1 members shall have a demonstrated knowledge of and interest in the health, human service,  
2 educational, or employment issues that affect immigrants residing in San Francisco, for a two-  
3 year term ending June 6, 2006.
