

1 [Accept-Expend California State Coastal Conservancy, San Francisco Bay Conservancy  
2 Program Grant Funds]

3 **Resolution authorizing the San Francisco Public Utilities Commission (SFPUC) to**  
4 **accept and expend a grant in the amount of \$125,000 from the California State Coastal**  
5 **Conservancy (CSCC) for the purchase and installation of restroom facilities for the**  
6 **Fifield-Cahill Ridge Trail project on the peninsula watershed in San Mateo County.**  
7

8 WHEREAS, In December of 2002; the San Francisco Public Utilities Commission  
9 adopted Alternative E (multi-use, supervised access) as the trail access alternative for the  
10 Fifield-Cahill Ridge Trail by resolution No. 02-0265, and

11 WHEREAS, The San Francisco Public Utilities Commission directed staff to seek  
12 additional funding opportunities from sources such as grants, contributions, or cooperative  
13 funding agreements with governmental agencies, institutions or other entities interested in  
14 jointly funding this project; and,  
15

16 WHEREAS, SFPUC staff have worked closely with the Bay Area Ridge Trail Council  
17 and the California State Coastal Conservancy to explore available funding opportunities that  
18 could be utilized to fund the necessary improvements for the Fifield-Cahill Ridge Trail project  
19 as authorized by the SFPUC; and,

21 WHEREAS, The California State Coastal Conservancy board at its June 4, 2003  
22 meeting adopted the resolution included in the staff recommendation approving the execution  
23 of a grant funding agreement for this project of up to \$125,000; and,

5 and,


6 WHEREAS, The SFPUC has authorized the General Manager to execute this funding

11 grant budget; and be it


12 FURTHER RESOLVED, The Board of Supervisors authorizes the General Manager of




