9 WHEREAS, San Francisco Community Power is a non-profit organization that seeks to
10 reduce and better manage energy use in San Francisco's southeast sector; and,

11 WHEREAS, The City and County of San Francisco funded San Francisco Community
12 Power to promote energy conservation through such initiatives as replacing old appliances
13 and distributing energy efficient lighting fixtures and light bulbs; and,

14 WHEREAS, San Francisco Community Power has trained and employed community
15 members to conduct energy audits and replace inefficient fixtures; and,

16 WHEREAS, San Francisco Community Power places particular emphasis on
17 educating the community about low-impact energy alternatives and helping to motivate
18 community support for sustainable energy policies, particularly the innovative *Electricity*
19 *Resource Plan* promoted by the San Francisco Department of the Environment; and,

20 WHEREAS, San Francisco Community Power has replaced thousands of lighting
21 fixtures, refrigerators, and heaters, saving millions of kilowatt-hours of electricity use; and,

22 WHEREAS, San Francisco Community Power helped to install one of the largest
23 privately-financed photovoltaic systems in the City; and,

1 WHEREAS, San Francisco Community Power advocated for and implemented a
2 unique residential dynamic pricing pilot as a means of demonstrating to the community and
3 policy makers how better energy management can help support efforts to close the heavily
4 polluting generating stations located in Hunters Point and Potrero; and,

5 WHEREAS, On October 5, 2004 San Francisco Community Power will celebrate its
6 third year of helping to conserve energy, educating the public about the benefits of clean
7 energy and energy conservation, and providing the tools San Franciscans need to create a
8 cleaner energy future; now, therefore, be it

9 RESOLVED, that the San Francisco Board of Supervisors hereby extends its highest
10 commendation to San Francisco Community Power for its dedication and commitment to a
11 sustainable energy future; and,

12 BE IT FURTHER RESOLVED, that the San Francisco Board of Supervisors hereby
13 proclaims October 5, 2004 San Francisco Community Power Day.
