6 WHEREAS, The City and County of San Francisco has created by charter,  
7 ordinances, resolutions and other means, numerous boards, committees, task forces, or  
8 other multi-member subordinate bodies; and,

10 WHEREAS, A comprehensive list of these legislative, policy, and other bodies  
11 does not currently exist; and,

12 WHEREAS, Health and dental benefits, salaries, stipends, staff support, and  
13 capital outlay for these bodies has not been cumulated in any organized manner; and,  
14

15 WHEREAS, The City and County of San Francisco has a legislative and fiduciary  
16 responsibility to from time to time review the various legislative, policy, and other bodies  
17 to determine whether or not the responsibilities, funding needs, and consistency in  
18 service support are in order; and,

19 WHEREAS, A comprehensive list of these organizations and supporting costs  
20 may lead to opportunities to streamline and provide cost savings, including, but not  
21 limited to, eliminating duplication of services; and,  
22

23 WHEREAS, An opportunity to review the various levels of staff classifications  
24 supporting these legislative, policy, and other bodies is also warranted; now, therefore, be it

1 RESOLVED, That the Board of Supervisors urges the City Controller to prepare a  
2 report delineating a total list of the legislative, policy, and other bodies, benefits, salaries,  
3 stipends, staffing support and classifications; and, be it

4 FURTHER RESOLVED, That the City Controller provide this information as soon as  
5 possible to be considered during Board of Supervisors' Budget Committee deliberations.


