RESOLUTION NO. 60-05

1 [Parking Regulations.]

2 **Resolution enacting and rescinding parking regulations at various locations.**

3
4 RESOLVED, That, in accordance with the provisions of the California Vehicle
5 Code and the San Francisco Traffic Code, the following regulations governing the
6 parking of vehicles are hereby enacted or rescinded as designated below:
7

8 **TOW-AWAY, NO PARKING FROM 10 PM TO 6 AM - ESTABLISH**

9 Florida Street terminus, north of 15th Street.

10 **TOW-AWAY, NO STOPPING ANYTIME – ESTABLISH**

11 Florida Street, west side of the easterly divided roadway, from 210 feet south of
12 15th Street, northerly to a point 18 feet south of the roadway terminus.

13 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

14 15th Street, north side, from Florida to Bryant Streets.

15 **PERPENDICULAR (90-DEGREE ANGLE) PARKING ESTABLISH**

16 Florida Street terminus, north of 15th Street;

17 Van Dyke Avenue, north side, between Keith and Jennings Streets; and

18 Divisadero Street, both sides, from 240 feet north of 14th Street to 240 feet south
19 of Duboce Avenue.

20 **TOW-AWAY, NO STOPPING, 7 AM TO 9 AM, MONDAY THROUGH FRIDAY –**
21 **RESCIND**

22 Lincoln Way, south side, from 20th Avenue to a point approximately 100 feet
23 easterly.

24 **TOW-AWAY, NO STOPPING ANYTIME – ESTABLISH**

25 Lincoln Way, south side, from 19th Avenue to a point 100 feet westerly.

1 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

2 Rousseau Street, east side, from San Jose Avenue to 55 feet southerly; and

3 Rousseau Street, west side, from San Jose Avenue to Bosworth Street.

4 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

5 Carl Street, north side, from 13 feet to 27 feet east of Willard Street
6 (accommodating 4 motorcycles while addressing sight distance concerns
7 at the intersection); and

8 Page Street, north side, between the driveways of 940 and 932 - 936 Page
9 Street, accommodating two unmetered motorcycle parking spaces.

10 **TOW-AWAY, NO STOPPING, 7 AM - 7 PM, EVERYDAY - RESCIND**

11 **TOW-AWAY, NO STOPPING, 3 PM - 7 PM, MONDAY THROUGH FRIDAY -
ESTABLISH**

12 McAllister Street, north side, from Gough Street to 60 feet easterly

14 ~~Mansell Street, median noses, east and west sides, at Girard, Brussels,
15 Goettingen, Somerset, Hamilton and Bowdoin Streets.~~

16 **PARKING METER AREA NO. 3 (2-HOUR PARKING TIME LIMIT, 9 AM - 6 PM,
17 MONDAY THROUGH SATURDAY) - ESTABLISH**

18 Bryant Street, both sides, between 15th and 16th Streets.

19 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

20 Genessee Street, west side, from Monterey Boulevard to 19 feet southerly.

21 **1-HOUR TIME LIMIT, 9 AM TO 6 PM, MONDAY THORUGH SATURDAY - RESCIND**

22 **2-HOUR TIME LIMIT, 9 AM TO 6 PM, MONDAY THORUGH SATURDAY -
ESTABLISH**

23 20th Street, both sides, between Capp and Valencia Streets (parking meters to
24 remain).

25 **TOW-AWAY, MONDAY THROUGH FRIDAY, 4 PM TO 6 PM - RESCIND**

Fell Street, south side, from Laguna Street to Scott Street.

2 **TOW-AWAY, MONDAY-FRIDAY, 4 PM-7 PM - ESTABLISH**

3 Fell Street, south side, from Divisadero Street to 125 feet easterly.

4 **RESIDENTIAL PERMIT PARKING AREA "I" (2-HOUR TIME LIMIT, 9 AM - 6 PM,**
5 **MONDAY THROUGH SATURDAY) - ESTABLISH**

6 Capp Street, both sides, between 17th and 18th Streets (200 block) (excludes the
7 thru-lot of 2155 Mission Street).

8 **RESIDENTIAL PERMIT PARKING AREA "Z" (2-HOUR TIME LIMIT, 8 AM - 6 PM,**
9 **MONDAY THROUGH FRIDAY) - ESTABLISH**

10 Church Street, both sides, between 25th and Jersey Streets (1200 block);

11 Duncan Street, both sides, between Sanchez Street and Noe Street (400 block);
12 and

13 Sanchez Street, both sides, between 28th and Duncan Streets (1400 block).

14 **RESIDENTIAL PERMIT PARKING AREA "G" (2-HOUR TIME LIMIT, 8 AM - 6 PM,**
15 **MONDAY THROUGH FRIDAY) - ESTABLISH**

16 Baker Street, both sides, between Geary Boulevard and Post Street
17 (1300 block).



5 Ocean Avenue, both sides, between 20th and 21st Avenues (2800 block).

6 Categorically exempt from Environmental
7 Review Class 1(c)(9) changes in the traffic and
8 parking regulations where such changes do not
9 establish a higher speed limit or result in more
10 than a negligible increase in the use of the
11 street.

TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH
Rousseau Street, east side, from San Jose Avenue to 55 feet southerly; and

Rousseau Street, west side, from San Jose Avenue to Bosworth Street.

UNMETERED MOTORCYCLE PARKING - ESTABLISH
Carl Street, north side, from 13 feet to 27 feet east of Willard Street (accommodating 4 motorcycles while addressing sight distance concerns at the intersection); and

Page Street, north side, between the driveways of 940 and 932 - 936 Page Street, accommodating two unmetered motorcycle parking spaces.
