2 for incarcerated mothers and their children in the county jail and after their release.]

3 **Resolution authorizing the Sheriff's Department to accept and expend a grant in the**
4 **amount of \$30,000 from the Zellerbach Family Foundation for providing family literacy**
5 **services to mothers incarcerated in the county jail and their children.**

6 WHEREAS, The Zellerbach Family Foundation has made available funding for family
7 literacy programs; and,

8 WHEREAS, Due to the need for improved literacy and strengthened family bonds
9 among incarcerated mothers and their children, the Sheriff's Department will provide a
10 program to support family literacy development for incarcerated mothers and their children;
11 and,

12 WHEREAS, The grant does not require matching funds; and,

13 WHEREAS, The Sheriff's Department proposes to maximize use of available grant
14 funds on program expenditures by not including indirect costs in the grant budget; now,
15 therefore, be it

16 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs
17 in the grant budget; and be it


18 FURTHER RESOLVED, That a grant award notification has been received from the
19 Zellerbach Family Foundation; and, be it

20 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
21 Francisco authorizes the Sheriff's Department to accept and expend \$30,000 in grant funds
22 from the Zellerbach Family Foundation; and be it

23 FURTHER RESOLVED, That the City and County of San Francisco will adhere to the
24 requirements of the Zellerbach Family Foundation and all conditions specified in the grant
25 agreement.






