3 **Resolution authorizing the Municipal Transportation Agency to accept and expend**  
4 **\$212,490 of funds from the Metropolitan Transportation Commission to perform site**  
5 **preparation work at San Francisco Municipal Railway facilities necessary for the**  
6 **installation of TransLink® equipment.**

7 WHEREAS, TransLink® is an automated regional fare payment system in the Bay  
8 Area that allows transit riders to use a single high-tech "smart card" to pay fares on different  
9 public transit systems; and,

10 WHEREAS, The TransLink® Consortium, comprised of various Bay Area transit  
11 agencies, including the Metropolitan Transportation Commission (MTC), and the City and  
12 County of San Francisco, through its Municipal Transportation Agency (MTA), is a forum for  
13 joint agency decision-making for the ownership and operation of TransLink® in the Bay Area;  
14 and,

15 WHEREAS, MTC has grant funding available to support efforts by Bay Area transit  
16 operators to perform site preparation work necessary for the installation of TransLink®  
17 equipment, including \$212,490 for site preparation work at Municipal Railway (MUNI) facilities  
18 by City employees; and,

19 WHEREAS, The governing body of the TransLink® Consortium, the TransLink®  
20 Management Group, has approved expenditures for TransLink® site preparation at MUNI  
21 facilities, to be performed by City employees; and

22 WHEREAS, The City and County of San Francisco, through MTA, is an eligible  
23 recipient for funding as a participating transit operator in the TransLink® project; now,  
24 therefore be it,

1 RESOLVED, That the Board of Supervisors authorizes the Municipal Transportation  
2 Agency to accept and expend \$212,490 of MTC funds to enable MUNI and other City  
3 employees to perform site preparation work at Muni facilities necessary for the installation of  
4 TransLink® equipment.




