6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated persons to serve as members of the Arts
8 Task Force, pursuant to the provisions of Resolution No. 781-04, for the term specified:

9 Kristine Keefer, new appointment, seat 12, must be an artist working the San Francisco
10 Bay Area, for the unexpired portion of a six-month term ending July 1, 2005.

11 Ronald Gallman, new appointment, seat 13, must serve as a director, staff member or
12 board member of a non-profit arts organization based in San Francisco with an annual budget
13 exceeding five million dollars, for the unexpired portion of a six-month term ending July 1,
14 2005.

15 David Gluck, new appointment, seat 14, must serve as a director, staff member or
16 board member of non-profit arts organization based in San Francisco with an annual budget
17 between one million dollars and five million dollars, for the unexpired portion of a six-month
18 term ending July 1, 2005.

19 Diane Cullinan, new appointment, seat 15, must serve as a director, staff member or
20 board member of a non-profit arts organizations based in San Francisco with an annual
21 budget between \$250,000 and one million dollars, for the unexpired portion of a six-month
22 term ending July 1, 2005.

23 Marc Vogl, new appointment, seat 16, must serve as a director, staff member or board
24 member of a non-profit arts organization based in San Francisco with an annual budget less
25 than \$250,000, for the unexpired portion of a six-month term ending July 1, 2005.


