7 WHEREAS, The Bay Area is subject to various earthquake-related hazards such as  
8 ground shaking, liquefaction, landsliding, fault surface rupture, and tsunamis; and,

9 WHEREAS, The Bay Area is subject to various weather-related hazards including  
10 wildfires, floods, and landslides; and,

11 WHEREAS, The City and County of San Francisco recognizes that disasters do not  
12 recognize city, county, or special district boundaries; and,

13 WHEREAS, The City and County of San Francisco seeks to maintain and enhance  
14 both a disaster-resistant community and region by reducing the potential loss of life, property  
15 damage, and environmental degradation from natural disasters, while accelerating economic  
16 recovery from those disasters; and,

17 WHEREAS, The City and County of San Francisco is committed to increasing the  
18 disaster resistance of the infrastructure, health, housing, economy, governments services,  
19 education, environment, and land use systems in the City as well as in the Bay Area as a  
20 whole; and,

21 WHEREAS, The Federal Disaster Mitigation Act of 2000 requires all cities, counties,  
22 and special districts to have adapted a Local Hazard Mitigation Plan to receive disaster  
23 mitigation funding from FEMA; and,

24 WHEREAS, The Association of Bay Area Governments (ABAG) has approved and  
25 adopted the ABAG report "Taming Natural Disasters" as the multi-jurisdictional Local Hazard
