3 **Resolution authorizing the Department of the District Attorney of the City and County**
4 **of San Francisco to retroactively accept and expend a grant in the amount of \$290,562**
5 **through the California Governor’s Office of Criminal Justice Planning (OCJP A301) for**
6 **the operation of a program entitled “Vertical Prosecution Program.”**

8 WHEREAS, The City and County of San Francisco desires to continue a certain project
9 designated the San Francisco Vertical Prosecution Program, to be funded in part from funds
10 made available through the Governor’s Office Criminal Justice Planning (OCJP A301); and,

11 WHEREAS OCJP A301 requires that the City and County of San Francisco, through
12 the Office of the District Attorney, provide no less than a twenty percent in-kind match for the
13 grant; and

14 WHEREAS, All positions supported by these funds shall be coded “G” in the District
15 Attorney’s budget; and,

16 WHEREAS, The terms of the grant prohibit inclusion of indirect costs in the grant
17 budget; now, therefore, be it

18 **RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of the City**
19 **and County of San Francisco to retroactively accept and expend funds from OCJP A301 for**
20 **the purposes of its vertical prosecution program; and, be it**

21 **FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of**
22 **indirect costs in the grant budget; and be it**

23 **FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of**
24 **the City and County of San Francisco the necessary Grant Award Agreements for purposes of**


1 its vertical prosecution program, including any extensions, augmentations or amendments
2 thereof; and be it

3 FURTHER RESOLVED, That the District Attorney is authorized and empowered to
4 execute, deliver and perform, in the name of the City and County of San Francisco, all
5 applications, contracts, agreements, amendments and payment requests necessary for the
6 purpose of securing Vertical Prosecution Program grant funds and to implement and carry out
7 the purposes specified in the applicable grant application; and be it

8 FURTHER RESOLVED, That any liability arising out of the performance of the Grant
9 Award Agreement, including civil court actions for damages, shall be the responsibility of the
10 grant recipient and the authorizing agency; and be it

11 FURTHER RESOLVED, That grant funds received hereunder shall not be used to
12 supplant expenditures controlled by this body.


