12 or officer of a core PDR Back Streets business located in San Francisco, for the unexpired  
13 portion of a two-year term ending November 16, 2006.

14 Mark Dwight, new appointment, seat 4, must be an officer or representative of an  
15 organization that represents San Francisco businesses, for the unexpired portion of a two-  
16 year term ending November 16, 2006.

17 David Lupo, new appointment, seat 5, must be an officer or representative of a labor  
18 union or other labor organization, for the unexpired portion of a two-year term ending  
19 November 16, 2006.

20 My Do, new appointment, seat 6, must be an officer or representative of an economic  
21 development or planning organization or association, or of an academic institution, for the  
22 unexpired portion of a two-year term ending November 16, 2006.

23 Peter Cohen, new appointment, seat 7, must be a person who has a demonstrated  
24 interest in and knowledge pertaining to Back Street businesses, for the unexpired portion of a  
25 two-year term ending November 16, 2006.




