20 November 23, 2007.

21 Karen Nolan, new appointment, seat 5, must be raising a family in western SoMa, for
22 the unexpired portion of a three-year term ending November 23, 2007.

23 Jim Berk, new appointment, seat 6, must be a senior residing in western SoMa, for the
24 unexpired portion of a three-year term ending November 23, 2007.

1 Frank McGrath, new appointment, seat 7, must operate a local business in western
2 SoMa, for the unexpired portion of a three-year term ending November 23, 2007.

3 April Veneracion, new appointment, seat 8, must work with a community-based

12 Charles Breidinger, new appointment, seat 12, must be a for-profit developer, for the
13 unexpired portion of a three-year term ending November 23, 2007.

14 Marc Salomon, new appointment, seat 13, must be a bicycle advocate, for the
15 unexpired portion of a three-year term ending November 23, 2007.




