7 WHEREAS, HARVEY V. BERNEKING was a longtime San Francisco resident with a
8 passion for many things that enhance and improve the culture and well being of our society
9 including classical music, anthropology and Victorian architecture, who passed away in May,
10 2002; and,

11 WHEREAS, HARVEY V. BERNEKING's estate is held in the HARVEY V. BERNEKING
12 Living Trust dated May 19, 1998, as amended; and

13 WHEREAS, HARVEY V. BERNEKING generously included the San Francisco Public
14 Library among the beneficiaries of the HARVEY V. BERNEKING Living Trust, many of which
15 were health services providers; and

16 WHEREAS, the San Francisco Public Library has received a distribution of \$100,000
17 from the HARVEY V. BERNEKING Living Trust; and

18 WHEREAS the subject gift of \$100,000 from the HARVEY V. BERNEKING Living Trust
19 would provide for needed improvements to the air quality systems for the Main Library which
20 would improve the health and comfort of Library users; and




1 WHEREAS, the City recognizes the generosity of HARVEY V. BERNEKING with


4 RESOLVED, that the Board of Supervisors hereby authorizes the City Librarian of San
