9 **MULTIPLE TURN LANES - RESCIND**

10 Beale Street, southbound, at Mission Street;

11 Battery Street, southbound, at Clay Street;

12 Clay Street, eastbound, at Battery Street; and,

13 Kearny Street, northbound, at Bush Street.

15 **NO TURN ON RED, 4 PM TO 6 PM, MONDAY THROUGH FRIDAY - RESCIND**
NO TURN ON RED, 4 PM TO 7 PM, MONDAY THROUGH FRIDAY - ESTABLISH

16 8th Street at Bryant Street

18 **LEFT LANE MUST TURN LEFT - ESTABLISH**

19 Franklin Street, northbound, at Bay Street
20

21 Categorically exempt from Environmental
22 Review Class 1(c)(9) changes in the traffic and
23 parking regulations where such changes do not
24 establish a higher speed limit or result in more
25 than a negligible increase in the use of the
street.


