12 WHEREAS, The Redevelopment Agency is subject to the Public Records Act,
13 Government Code Section 6250 et seq., and the Brown Act, Government Code Section
14 54950 et seq., and not subject to the San Francisco Sunshine Ordinance, San Francisco
15 Administrative Code Section 67.1 et seq.; and,

16 WHEREAS, Under the CRL, a redevelopment plan authorizes, among other things, the
17 land uses and controls for development in redevelopment project areas; now, therefore, be it




