9 WHEREAS, IN 2001, The Board of Supervisors authorized the Department on the
10 Status of Women to accept and expend a grant of \$145,475 from The California Endowment
11 to establish a centralized, 24-hour multi-language domestic violence crisis line; and

12 WHEREAS, The Department has to date expended only \$105,475 of the grant funds;
13 and

14 WHEREAS, Woman Organized to Make Abuse Nonexistent, Inc. (W.O.M.A.N., Inc.) is
15 an essential provider of crisis line services to victims of domestic violence; and

16 WHEREAS, The California Endowment has approved the use of the unexpended
17 \$40,000 in grant funds for use by W.O.M.A.N., Inc. to design and implement a customized
18 plan for raising multiple year operating funds with the goal of providing the organization long-
19 term self-sufficiency; now, therefore, be it

20 RESOLVED, That the Board of Supervisors hereby authorizes the Executive Director
21 of the Department on the Status of Women to accept retroactively and expend unexpended
22 funds from a grant from the California Endowment, in the amount of \$40,000, which funds
23 shall be used to fund the design and implementation of a customized plan for raising multiple
24 year operating funds by Woman Organized to Make Abuse Nonexistent, Inc. (W.O.M.A.N.,
