3 Resolution authorizing the Department of Parking and Traffic to
4 retroactively accept and expend a grant in the amount of \$500,000 from
5 the Metropolitan Transportation Commission (MTC) to integrate the SFgo
6 Transportation Management Center (TMC) with Caltrans District 4 in
7 Oakland and 511 to exchange real-time transportation information.

9 WHEREAS, The SFgo Program is a Citywide transportation management
10 system that will gather real-time information on traffic flow and
11 congestion, process and analyze this information, respond to changes in
12 roadway conditions, and disseminate information to the public; and,

13 WHEREAS, Participation in the Metropolitan Transportation
14 Commission's (MTC's) Interim Center-to-Center Project will allow SFgo to
15 exchange real-time information with the Caltrans Transportation
16 Management Center in Oakland, 511 and other transportation management
17 systems throughout the Bay Area; and,

18 WHEREAS, The Metropolitan Transportation Commission (MTC) recently
19 allocated \$500,000 in Congestion Management and Air Quality (CMAQ) funds
20 for SFgo to join the Interim Center-to-Center Project; and,

21 WHEREAS, The Metropolitan Transportation Commission (MTC) recently
22 allocated \$500,000 in Congestion Management and Air Quality (CMAQ) funds
23 for SFgo to join the Interim Center-to-Center Project; and,

1 WHEREAS, The San Francisco County Transportation Authority recently
2 approved \$70,000 from SFgo's Proposition K Sales Tax Funding as the
3 required local match; and,

4 WHEREAS, The Municipal Transportation Agency (MTA) Board recently
5 accepted the \$500,000 in Congestion Management and Air Quality (CMAQ)
6 funds from the MTC for SFgo to join the Interim Center-to-Center Project;
7 and,

8 WHEREAS, The Department of Parking and Traffic will set and manage
9 the requirements for the software and hardware that will be procured with
10 the funding; and,

11 WHEREAS, The Department proposes to maximize use of available grant
12 funds on program expenditures by not including indirect costs in the
13 grant budget; now, therefore, be it

14 RESOLVED, That the Board of Supervisors authorizes the Director of
15 Transportation or his designee accept and expend \$500,000 in grant
16 funding from the Metropolitan Transportation Commission (MTC) to
17 integrate the SFgo Transportation Management Center (TMC) with Caltrans
18 District 4 in Oakland and 511 to exchange real-time transportation
19 information.


