3 **Resolution authorizing the Sheriff's Department to accept and expend a continuation**
4 **grant in the amount of \$76,283 from the Private Industry Council of San Francisco for**
5 **providing employment and education services to young offenders and after their**
6 **release from the county jail.**

7 WHEREAS, The Private Industry Council of San Francisco has made available funding
8 for youth programs; and,

9 WHEREAS, Due to the need for education and job development among young
10 offenders, the Sheriff's Department will provide a program to support academic, vocational,
11 and personal development for young offenders after their release from custody; and,

12 WHEREAS, The grant does not require matching funds; and,

13 WHEREAS, The Sheriff's Department proposes to maximize use of available grant
14 funds on program expenditures by not including indirect costs in the grant budget; now,
15 therefore, be it

16 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in
17 the grant budget; and be it

18 FURTHER RESOLVED, That a grant award notification has been received from the
19 Private Industry Council of San Francisco; and, be it


20 FURTHER RESOLVED, That the grant provides for the creation of a part-time position
21 as follows: 0.5 FTE Principal Administrative Analyst at a salary of \$3,436 bi-weekly plus
22 benefits; and, be it

23 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
24 Francisco authorizes the Sheriff's Department to accept and expend \$76,283 in grant funds
25 from the Private Industry Council of San Francisco; and be it
