8 WHEREAS, Jerry Garcia of the "Grateful Dead" grew up in the Excelsior District and
9 frequented McLaren Park as a child; and,

10 WHEREAS, The Jerry Garcia Estate has assisted greatly in the promotion of
11 McLaren Park and the improvement of the Excelsior through its generous donation of Jerry
12 Garcia's artwork in 2001 for a T-shirt to fundraise for the rebuild of Crocker Amazon Park;
13 and,

14 WHEREAS, On October 29, 2005, the amphitheater at McLaren Park will be officially
15 renamed the Jerry Garcia Amphitheater, the only public facility in the United States to be
16 named after Jerry Garcia; and,

17 WHEREAS, A group of dedicated community members and neighbors from Districts 9,
18 10, and 11 have been working diligently to rename the amphitheater in honor of Jerry Garcia
19 and to organize a celebration to highlight the official dedication; and,

20 WHEREAS, The renaming of the amphitheater is part of a larger on-going effort by
21 tremendously active and concerned neighbors and park lovers to promote and increase the
22 use of McLaren Park; now, therefore, be it

23 **RESOLVED**, That the Board of Supervisors of the City and County of San Francisco
24 does hereby commend the Jerry Garcia Estate for its generous efforts to promote and
25 improve McLaren Park and the Excelsior; and be it


