3 **Resolution authorizing the San Francisco Department of Public Health (SFPDH), to**  
4 **accept and expend a new grant in the amount of \$563,195 from the California Office of**  
5 **Traffic Safety (COTS) to improve child passenger safety in San Francisco, to enter into**  
6 **an agreement for the use of these funds, and to add one (1.0) position funded through**  
7 **this grant agreement; for the period of October 1, 2005, to December 31, 2007.**

9 WHEREAS, SFPDH has applied for and been awarded a grant in the amount of  
10 \$563,195 from COTS to improve child passenger safety in San Francisco; and,

11 WHEREAS, As a condition of receiving the grant funds, COTS requires the City to  
12 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the  
13 Board of Supervisors in File No. 051839; which is hereby declared to be a part of  
14 this resolution as if set forth fully herein; and,

15 WHEREAS, One (1.0) position will be added through this grant; and,

16 WHEREAS, The grant budget includes a provision for indirect costs of \$36,876; now,  
17 therefore, be it

18 RESOLVED, That SFPDH is hereby authorized to accept and expend a grant in the  
19 amount of \$563,195 from COTS; and, be it


20 FURTHER RESOLVED, That SFPDH is hereby authorized to accept and expend the  
21 grant funds in accordance with the requirements set forth in the Agreement, pursuant to San  
22 Francisco Administrative Code section 10.170-1; and, be it

23 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
24 agreement on behalf of the City; and, be it

1 FURTHER RESOLVED, That SFDPH is hereby authorized to add one (1.0) position  
2 funded through this agreement; and, be it

3 FURTHER RESOLVED, That the Controller is directed to designate the positions  
4 funded under this agreement as "G" or grant-funded positions which would terminate when  
5 the agreement expires.






