3 **Resolution designating certain intersections as "STOP" intersections.**

4 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the  
5 following intersections are hereby designated as "STOP" intersections, and the Department of  
6 Parking and Traffic is hereby authorized and directed to cause "STOP" signs to be installed  
7 thereat as designated below:

8 **STOP SIGNS - ESTABLISH**

10 Pierce and Fulton: stopping northbound and southbound at Pierce Street, and  
11 eastbound and westbound at Fulton Street, making this intersection an All-Way  
STOP;

12 4<sup>th</sup> Ave. at Hugo: stopping northbound and southbound 4<sup>th</sup> Ave. and eastbound and  
13 westbound Hugo, making this intersection an All-Way STOP;

14 Octavia at Fulton: stopping eastbound and westbound at Octavia Street ;—.

15 ~~Stanyan at Alma: stopping northbound and southbound traffic at Stanyan at Alma St;~~




